



The Founding Storγ of Next Food Collective

Next Food Collective was born from a shared vision: to maximize the impact of innovation programmes and drive meaningful change in the food industry. In 2022, this vision united four influential organizations - SFI, TiFN, CCC, and PCC - who made the bold decision to join forces. The legal merger of TiFN and SFI on March 7, 2023, marked the first concrete step toward creating a new, unified force in sustainable and healthy food innovation. For decades, these organizations had excelled in fostering public-private collaborations, but there was a clear need to shift gears.

The official launch of Next Food Collective on May 23, 2023, was a milestone moment, hosted at Innocent's The Blender factory on the Maasvlakte. Partners and stakeholders came together to celebrate this new beginning, marked by the unveiling of the Collective's logo, a symbol of unity among the four merging organizations, and the launch of its website.

Next Food Collective represents more than a merger; it is the start of a powerful movement to reshape the future of food.

Themes



DRIVING TRANSFORMATION: Four strategic themes for a future-proof food system

Our four themes, strategically defined at the first Core Partner Board meeting, are grounded in the key transformations required to reshape the global food system. These include a shift in consumption toward more sustainable and healthier diets, as well as the need for a food production system that operates within environmental and climate boundaries.

To address these challenges, Next Food Collective focuses on sustainable agriculture, sustainable processing, healthy nutrition and wellbeing, and the protein transition critical areas for driving meaningful and lasting change.

Together, these focus areas create opportunities for impactful innovation, cross-sector collaboration, and systemic change to future-proof the agri-food sector.

2023 HIGHLIGHTS & FOUNDING STORY



1. Sustainable Agriculture



Dutch agriculture's focus on super-efficient production has been profitable but goes hand in hand with negative effects on nature. A transition is needed to a regenerative agricultural system that will enable us to produce food in balance with nature, people, the climate and the economy of the future. In addition, we need to drastically reduce environmental costs and create worthwhile new employment opportunities as well as exportable products and services.

The Re-Ge-NL programme is the main 2023 highlight for the Sustainable Architecture theme of Next Food Collective.

We were thrilled to celebrate the unconditional approval of the Re-Ge-NL programme '2024-2030' for the Dutch National Growth Fund in October 2023. During the partner event on November 3, the Re-Ge-NL core team was recognized and celebrated for this grant.



This iconic impact project will receive a grant of

€ 129 million from the Growth Fund.



Sustainable agriculture is essential to transforming our food system, with farmers leading the way in balancing food production with the needs of nature, people, and the climate. By adopting regenerative practices, we can produce food within planetary boundaries, drive innovation, and unlock new opportunities.

At Next Food Collective, we view sustainable agriculture as a cornerstone of our 2030 vision: creating an agri-food sector that thrives by producing high-quality, sustainable, healthy, and affordable food for all. Together with 50 partners, we successfully submitted the ReGeNL proposal and it has been granted. We look forward to collaborating with the ReGeNL partners and as many farmers as possible to develop a future-ready, regenerative agricultural sector."

The Synergia programme '2021-2027', focusing on technology-for-ecology-based farming (€ 6.2 million), was initiated at TiFN during the COVID-19 pandemic.

Led by Peter Groot Koerkamp (WUR), the programme aims to build and integrate fundamental knowledge from life, technological and social sciences, and provide the technological methods, tools, and human capacities to facilitate acceptance and transition of new production systems into the market.

Three usecases will be developed, representing the variety of agricultural systems: greenhouse horticulture, dairy production and field crops.



2. Sustainable Processing



At the time of the launch of Next Food Collective, we started the development of this new theme. Recognizing the valuable work already being undertaken by ISPT on various processing challenges, it was decided to collaborate with partners to create a shared vision.

This vision was presented to the Core Partner Board on November 3, highlighting key priorities:

- 1. Accelerating CO₂ reduction to achieve 'net zero.'
- 2. Preventing, reducing, and upgrading industrial side streams.
- 3. Embracing mild(er) refining processes.
- 4. Redesigning ingredients to maintain functionality while minimizing their environmental footprint (water and CO₂).



The integration of AI and data science emerged as a significant opportunity identified by partners, offering immense potential for accelerating innovation and nurturing the talent pipeline for the future.

On November 3, 2023, the Core Partner Board approved the transformation of this vision into a comprehensive programme for the 4th round of the National Growth Fund (NGF). A critical objective of this programme was to strengthen collaboration between stakeholders and counteract fragmentation within the sector. To this end, connections were established with WUR, Food Valley, and ISPT organizations that had previously initiated a growth fund programme.

By the end of December, all parties aligned, agreeing that the agri-food sector should unite behind a single initiative for the 4th round. This marks a pivotal step toward fostering cooperation and driving impactful innovation for the sector's future.

Healthγ Nutrition Wellbeing



Top institute Food and Nutrition (TiFN) and Carbohydrate Competence Center (CCC) bring a rich and extensive history to this topic, demonstrating their deep expertise and commitment. In 2023, several major projects were actively underway, with varying levels of support from Next Food Collective:

- 1. Processing and Overweight: Restructure and Meta-Pro
- 2. Sweetness and Overweight: Sweet Tooth
- 3. Carbohydrates, Gut Function, and Health Effects: Carbosupport
- 4. Lifestyle Interventions and Mental Health: Mocia

In November 2023, a working group comprised of (industrial) partners was formed to shape this vision. Their efforts are being followed up with further developments beginning in January 2024, paving the way for an inspiring and impactful direction for the theme.

4. Protein Transition



A sustainable and healthy food system requires a shift towards increasing the share of proteins from 'alternative' sources, such as plant-based and cellular agriculture, in our daily diet. The protein transition is gaining incredible momentum and we are seeing a wave of inspiring initiatives taking shape.

The Next Food Collective team, led by Stacy Pyett from WUR, did an outstanding job in 2023 with the submission of the Growth Fund program EPPIC, strategizing across three closely aligned platforms: agrotechnology, value chains, and global growth.

Although these efforts were not rewarded due to the non-approval of the programme, protein transition topics remain pivotal within the scope of Next Food Collective and will be addressed transversally across all our focus areas.

At Flora Food Group we are committed to offering delicious plant based products to our consumers that are natural, nutritious, affordable and sustainable. Therefore our R&D strategγ ensures we continue to push the boundaries on technologγ solutions and continue to drive the protein transition.



We built a core group of employed staff, consisting of both new hires and existing employees from TiFN, supplemented by freelancers and support services, such as IT and website management. Our structure took into account the planned expansion in 2024 of a ReGeNL team.



The Protein Transition theme will be seamlessly integrated into the other three themes
